- 5. Changes in the intensity of previous land uses e.g., increased night-time lighting and parking impact sports fields in Bayside.

- 6. Impact on heritage items and heritage conservation areas e.g., Ashfield, Mosman, Willoughby and Summer Hill.
- 7. Major modifications to large scale mixed development that will increase demand for services and facilities (public transport, preschools, schools, open space, community space and facilities) e.g. Eastgardens and Rockdale.

- Management of Mascot Local Centre Urban Design Strategy for Bayside Council (Conybeare Morrison).
- Preparation of a submission to the State government that resulted in funding for the Review of the (then) Botany Bay Heritage Study.
- Preparation of DAs for individual clients and organisations, including statements of environmental
 effects, to be lodged with various Councils e.g., Northcross Christian School at Ryde. This project
 required significant amendment and rationalisation of previous plans, lodgement of a series of DA's
